		 Updates on Medicaid Direct and Tailored Plan Trainings: Sarah Willhite (Training Development Manager) There are currently 24 Tailored Plan provider trainings approved by the state. The below listed trainings are aligned with the Medicaid PIHP Contract: Tailored Care Management for Youth in Foster Care, Receiving Adoption Assistance, or Former Foster Youth NC Medicaid Managed Care vs NC Medicaid Direct: What's the Difference?
	•	 Physical Health partner, Carolina Complete Health (CCH), to assist providers in understanding what the Tailored Plan is and answer provider questions. One session was held in September 2022 and another in January 2023. Jackie shared with the Provider Council how to access past informational session recordings and presentation slides. Network Adequacy: Adrienne Beatty (Director of Network Development)
		 Adrienne gave the Provider Council a brief update about where Trillium stands with its Tailored Plan Network Adequacy. Trillium has partnered with CCH to build a Physical Health Network; and great progress has been made.
