5. Agenda Topic: NCTracks Re-Verifications Presenter(s): Rebbecca Basden

Discussion	 Because provider credentialing and re-credentialing is completed outside of Trillium, Trillium is required to rely solely on the information that providers give within NCTracks as a part of provider enrollment.
	 For this reason, providers are encouraged to routinely check their NCTracks inbox and promptly respond to all notifications.
	 The Centers for Medicare and Medicaid Services require that every provider and clinician enrolled in Medicaid be re-credentialed (<i>In-State is every five years / Out-of-State is every year</i>). This process is commonly referred to as re-verification.
	• Providers are given 70 days to complete the reverification.
	• If not completed within 70 days, the provider will receive a notice of suspension by postal service mail and in their NCTracks inbox; the provider's status will be changed to suspended within NCTracks during this time.
	 Once suspended, the provider has 50 days to submit the re-verification application, and any provider that does not complete this process will become terminated.
	 Once a provider is terminated, they are no longer permitted to complete reverification, and must instead re-enroll by following the NCTracks enrollment process.
	• Re-enrolling does not guarantee a retro effective date, and a gap in the enrollment could occur.
